MEMBERSHIP DUES

Chorus membership includes a yearly membership fee to help with choir expenses. If you decide to join us, the yearly membership fee is \$25. Membership dues must be paid within 4 weeks of joining the chorus.

A \$50 music deposit is also required. All money will be held until the last week of rehearsal before the show. Once it has been verified that you have turned in your music, your deposit will be returned to you. If the music is not returned, the checks will be cashed (if paid by cash, it will be kept by the chorus). This deposit will be required in order to take your music home with you.

Checks should be made to "FWBCC" and given to the chorus Treasurer.

ADDITIONAL COSTS

The chorus makes every effort to keep the costs associated with required performance attire and optional costumes to a minimum. There is a one-time required purchase of a choir performance uniform. (Women's dress \$59, Men's vest/tie \$33). Payment arrangements can be made. Please see Jeanie Caughman.
